THIS COURT ORDERS that:



The British Columbia Claims Administrator is authorized to provide a copy of a claimant's file to counsel for Dow Corning and to Class Counsel, if, pursuant to Subparagraph 2.4(ii) of Exhibit D to the Dow Corning/British Columbia and Other Provinces Implant Litigation Settlement Agreement, a claimant provides other objective verification of the identification of the Dow Corning Breast Implant instead of Product Identification Documentation as outlined in Subparagraphs 2.4(i)(a), (b) or (c), in order to allow the Claims Administrator to consult with Class Counsel and Dow Corning Counsel for the purposes of making a determination;

2. Dow Corning Counsel and Class Counsel shall maintain the confidentiality of such documentation and information to the extent necessary to protect the identity and privacy of individual members of the British Columbia Class.

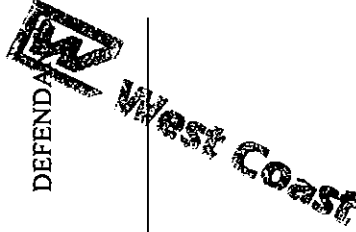
